Information to Applicants

The application form needs to be filled in and submitted to the Island Government. In order to be processed the form must bear a Naf 5.00 stamp available at the Island Receiver's Office (Eilandsontvanger). If the renovation permit is approved you will need a second Naf 5.00 stamp for the permit itself.

The following information should be submitted along with the application form:

- Letter describing in detail the reason for renovation, dimensions, the exact location of the renovation and the method of renovation;
- Plan including (kadastral) reference points;
- Renovation plan on scale;
- Detailed description of the method through which the work will be executed and precautions taken to prevent potential damage to the underwaterpark;
- Photographs of the location and/or renovation;
- Proof of premises ownership (eigendomsakte);
- Proof of payment of "leges"(Naf 25,- payable to the Island Receiver's Office);

Your application will not be processed in case a the application is not complete.

Note that in certain cases, in case a permit is granted, you will need to apply for a building permit (Bouwen Woningverordening Bonaire (A.B. 1961, no.17)) and apply to the minister of Finance (Curaçao) for permission to rent the sea bottom from the Central Government where the construction is located.

Please read carefully before completing the application form

Reason renovation is necessary: The necessity for renovation must be made apparent.

Location: Please be specific about the location of the construction to be renovated. You will need to submit a scale plan indicating the proposed location of the renovation including kadastral reference points and co-ordinates.

Renovation details: Please provide a detailed description of the type of renovation you require, the materials you will use and any other relevant information. In addition, you will need to submit scale plans of the renovation itself.

Method of renovation: Please describe the renovation method and the machinery to be used. Please note that piers and platforms should consist of a hard section (pillars and frame) and a soft section (demountable wooden deck). In addition, construction boats will generally not be considered by the Island Government of Bonaire.
